Responsible Internet Use – Essex Learning Platform Project (e-Folio)

The Department for Education and Skills recently announced a strategy for all schools to have access to a Learning Platform and online Learning Space by 2007-2008. Great Waltham School is taking part in the Essex Learning Platform project (e-Folio).

As part of the Project, your child is being provided with an electronic desktop which means that he/she will have a safe and secure password protected area on the World Wide Web where he/she will be able to save examples of their best work to. Since the electronic desktop is web based, your son/daughter will be able to access their work anywhere where they have access to a PC and the Internet, e.g. at school, home or in the library.

Please note: As with any secure internet account, it is important that your child's password is kept a secret. If however, you think that their account has been compromised in anyway, please contact the school directly.

Your child will have access to an e-mail account that is restricted to use within the school's e-folio environment. They will be taught how to use it responsibly. The school will take any allegations of bullying by e-mail very seriously. Any incidents will be dealt with in accordance with the schools Anti-bullying Policy.

Great Waltham School is already providing supervised access to the Internet and you will have already signed a Responsible Internet Use permission form. Our school Internet provider operates a filtering system that restricts access to inappropriate materials. This may not be the case at home. You may find it useful to visit web sites such as:

Responsible Use of e-folio

- I will ask permission before entering any Web site, unless my teacher has already approved that site.
- I will use only my own login and password, which I will keep secret.
- I will only e-mail people I know, or my teacher has approved.
- The messages I send will be polite and sensible.
- When sending e-mail, I will not give my home address or phone number, or arrange to meet someone.
- I will ask for permission before opening an e-mail or an e-mail attachment sent by someone I do not know.
- I will not use Internet chat except if it is a discussion room that has been set up by my teacher using e-folio.
- Any work I display using e-folio will be work that I know I would want my family and friends to see.
- If I see anything I am unhappy with or I receive messages I do not like, I will tell a teacher immediately.
- I know that the school may check my computer files and may monitor the Internet sites I visit.
- I understand that if I deliberately break these rules, I could be stopped from using the Internet or computers.

The school may exercise its right by electronic means to monitor the use of the school's computer systems, including the monitoring of web-sites, the interception of E-mail and the deletion of inappropriate materials in circumstances where it believes unauthorised use of the school's computer system is or may be taking place, or the system is or may be being used for criminal purposes or for storing text or imagery which is unauthorised or unlawful.
